In 2003, I was invited to serve as a Founding Director for End Violence Against Women International (EVAWI), a fledgling nonprofit dedicated to improving criminal justice responses to sexual assault and other forms of gender-based violence. In 2004, I assumed the role of Research Director, and I have since helped grow EVAWI into the premiere training organization on sexual assault investigations, providing superior training and resources, influencing national policy, and mentoring a new generation of leaders,

During my tenure, I have helped secure more than \$9.5 million dollars in public and private funding for EVAWI. I have also developed training materials and publications, and personally provided training and technical assistance for thousands of professionals in diverse fields, including law enforcement, victim advocacy, health care, and prosecution, in communities, on campuses, and in the U.S. military. In 2011, we expanded EVAWI's impact with the launch of Start by Believing, a public awareness campaign designed to transform the way society responds to victims of sexual violence. With campaigns in all 50 US states, several US territories and protectorates, and numerous countries, this vision is becoming a reality as the campaign changes the world for victims, one response at a time.
